Government Order

The undersigned is directed to convey the sanction of the Government, in favor of Dr. Md. Nazrul Islam, Additional Foreign Secretary (Bilateral-East and West), Ministry of Foreign Affairs, to undertake an official visit to Riyadh, Saudi Arabia from 01 July 2024 to 03 July 2024, to attend the Second Political Consultations between Bangladesh and the Kingdom of Saudi Arabia which will be held in Riyadh on 01 July 2024.

02. Terms and Conditions:

- a) He will depart from Dhaka for Riyadh, Saudi Arabia on 01 July 2024, or on a nearer date, and depart from Riyadh for Dhaka on 03 July 2024, or on a nearer date.
- b) The entire period of visit, including the time spent on travel and transit, will be treated as on duty.
- c) Admissible pay and allowances will be drawn in the local currency of Bangladesh.
- d) All relevant expenses in connection with the visit will be borne by the Ministry of Foreign Affairs from its budget allocation for FY 2024-25.
- e) He will not be allowed to stay in Riyadh beyond the approved period.


