Subject : Administrative order for official visit to the Netherlands on 6 March 2024 (excluding travel time)

I am directed to convey the administrative approval of the Government in your favour to pay an official visit to Hague, The Netherlands on 6 March 2024 (excluding travel time).

2. The terms & conditions of the approval are:

- a. The period of this visit and the time spent for travel and transit will be treated as on duty;
 - b. You will be entitled to airfare and other allowances as per existing rules. These expenses will be borne from the relevant budget head of the Ministry of Foreign Affairs' for the current FY2023-2024. The pay and allowances shall be paid in local currency of Bangladesh;
 - c. You will travel to the Netherlands, upon completion of 8th Meeting of the Joint Working Group (JWG) on implementation of EU- BD SOPs, 2nd meeting of the comprehensive Migration and Mobility Dialogue, and the 2nd Talent Partnership Roundtable between Bangladesh and the European Union in Brussels, on 5 March 2024 or nearby date and depart from the Netherlands on 7 March 2024 or nearby date;
 - d. You will not be allowed to stay abroad for more than the approved period.
3. This order is issued with approval of the competent authority.
