

The government of Bangladesh has nominated you to participate in the Exchange of Expertise on the theme of 'Blue Economy in the Gulf of Bengal' to be held from 23 January to 03 February (excluding travel & quarantine time) in Brussels, Belgium.

02. The Terms and Conditions are as follows:

- i. You will depart Dhaka for Belgium on 21 January 2023 or nearer date and you will depart Belgium for Dhaka on 04 February 2023 or nearer date after completion of the program;
- ii. The period of the program and time spent for travel and transit will be treated as on official duty and you will not be entitled to receive any allowances in foreign currency;
- iii. The travel expense for the participation in the said program will be borne by the Belgian Ministry of Foreign Affairs. In addition, other related expenditures (if any) will be borne by the Ministry of Foreign Affairs from the relevant budget head [(1180101-104125-3231301, training)] following the existing government rules and procedures;
- iv. You will not be allowed to stay abroad more than the approved period;
- v. If the duration of the program changes, you will immediately inform the Ministry and follow the instructions received from the Ministry;
- vi. You will have to submit a report to the R & T Section of the Ministry within the 05 (five) working days upon your return after completion of the program;
- vii. You have to report to the personnel section of the Ministry immediately after arrival in Bangladesh.
