

The undersigned is issuing Government of People's Republic of Bangladesh's approval for you to the participate in the "57th Session of Human Rights Council and Pre-session Induction Course" to be held from 04 September-11 October 2024 in Geneva, Switzerland.

02. The terms and conditions are as follows:

- The period of the program and time spent for travel and transit will be treated as on official duty and you will not be entitled to receive salary and any allowances in foreign currency;
- The air fare, daily subsistence allowance (DSA) will be borne by organization and all others expenses will be borne by the relevant budget head of this Ministry;
- You will not be allowed to stay abroad more than the approved period;
- You will have to submit a report to the Recruitment and Training Section of the Ministry within the 05 (five) working days upon your return after completion of the session;
- You will depart Dhaka for Geneva on 02 September 2024 or nearer date (to reach Geneva by 03 September as per OHCHR instruction) and start for Dhaka on 12 October 2024 or nearer date after completion of the session.

03. This order is issued with the approval of the competent authority.


