The undersigned is directed to convey the deputation order from 26 September 2023-15 October 2024 (Excluding traveling time) in your favour for studying "Master of Studies in Diplomatic Studies at University of Oxford, United Kingdom, under the Prime Ministers Fellowship 2023-2024.

02. The terms and conditions are as follows:

- i. The period of the course and time spent for travel and transit will be treated as on official duty and you will not be entitled to receive any allowances in foreign currency;
- ii. You will be entitled to full salary and allowances during your deputation period and you will draw your salary and allowances in local currency;
- iii. There will be no financial contribution from the Ministry for all expenses incurred by higher education including air fare;
- iv. You will not be allowed to stay abroad more than the approved period;
- v. Upon your return, you will not be nominated again for higher studies till completion of 01 (one) year in service. This condition shall not be applied for PhD and post-doctoral research;
- vi. You will have to submit a report along with your degree certificate to the R&T Section of the Ministry within the 05 (five) working days upon your return after completion of the course;
- vii. You will depart Dhaka for the United Kingdom on 26 September 2023 or nearer date, and you will depart the United Kingdom for Dhaka on 15 October 2024 or nearer date after completion of the course;
- viii. If the duration of the course changes, you will immediately inform the Ministry and follow the instructions received from the Ministry;
- ix. You have to report to the Personnel Section of the Ministry immediately after arrival in Bangladesh.
