The undersigned is conveying the Government of the People's Republic of Bangladesh's approval in your favour, for deputation (on higher studies) from 08 January 2024 to 31 December 2025 (excluding travel time) for studying 'Master in International Law and Diplomacy' at the Australian National University, Australia.

02. The Terms and Conditions are as follows:

- (i) The period of the course and time spent for travel and transit will be treated as on official duty and you will not be entitled to receive any allowances in foreign currency;
- (ii) You will be entitled to full salary and allowances during your deputation period and you will draw your salary and allowances in local currency;
- (iii) There will be no financial contribution from the Ministry for all expenses incurred by higher education including air fare;
- (iv) You will not be allowed to stay abroad more than the approved period;
- (v) Upon your return, you will not be nominated again for higher studies till completion of 01 (one) year in service. This condition shall not be applied for PhD and post-doctoral research;
- (vi) You will have to submit a report along with your degree certificate to the P&O Section of the Ministry within 05 (five) working days upon your return after the completion of the course;
- (vii) You will depart Dhaka on 07 January 2024 or nearer date, and you will depart for Dhaka on 31 December 2025 or nearer date after completion of the course;
- (viii) If the duration of the course changes, you will immediately inform the Ministry and follow the instructions received from the Ministry; and
- (ix) You have to report to the Personnel-1 Section of the Ministry immediately after your arrival in Bangladesh.
