

Subject: Government Order to visit Bosnia and Herzegovina from 30 January to 02 February 2023

2. The tour will be held under the following terms and conditions:
- a) They will leave Dhaka for Bosnia and Herzegovina on 29 January 2023 or on nearer date and leave Bosnia and Herzegovina for Dhaka on 02 February 2023 or on nearer date;
 - b) The period including transit will be treated as on duty;
 - c) All expenses will be borne by International Organization for Migration (IOM).
