


TRANSFORMING LIVES THROUGH INVESTING IN TECHNOLOGY


As a strategic partner, Startup Bangladesh Limited has developed its partnership with number of national and international stakeholders.



CRITERIA & TERMS OF INVESTING


- Startups having **Minimum Viable Product (MVP)** or emerging undertakings mainly involved in product, service or technology

- The company must have some **degree of innovation**, knowledge or strategy to remain competitive in the market.
- Having a worthy impact on the society as a whole.
