- i) All expenses regarding this visit will be borne by respective Ministry/Division/Authority/Organization;
- j) H.E. Ambassador, Embassy of the People's Republic of Bangladesh in Paris, France will join the Economic Forum from Paris. Therefore, this will not involve any additional expenses from the Bangladesh Government exchequer;

- k) They will leave Dhaka for Paris, France on 20 October 2019 or nearest possible date and leave Paris, France for Dhaka on 24 October 2019 or nearest possible date;
- l) They will have to submit a report to concerned authority within 15 days after their return from abroad;
- m) They will not be allowed to stay abroad more than the approved period.
