
Subject: Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favor of Ms. Laila Muntajeri Deena, Director (Welfare) of the Ministry of Foreign Affairs, Dhaka to visit Bucharest, Romania in connection with introducing e-Passport Systems in Bangladesh Mission in Bucharest, Romania from 10 October 2021 to 21 October 2021 (excluding transit and travel time) or nearest possible date.

- c) She will draw her usual pay and allowances from Bangladesh in local currency;
- d) All expenses will be borne from the travel expense budget of 2021-2022 fiscal year of Ministry of Foreign Affairs.


